Classes start Tuesday, September 4th.

Holiday Breaks: Halloween: NO CLASS; Fall Break: Tues, Nov. 20th – Sun, Nov 25th;
Winter Break: Thursday, Dec 20th – Wed, Jan. 2nd; **Spring Break:** TBA

TUITION: On Pointe has 35 scheduled lessons from September through May; 33 regular lessons and 2 built-in snow/emergency days. This schedule accounts for 3 holiday breaks; Fall, Winter, and Spring. **Students are not charged for snow days, holiday breaks, or additional rehearsals. Students are only charged for 33 lessons.** Tuition fees have been broken down into 7 payments paid September through March. *All fees for the year must be paid in full by March 7th.*

Tuition is due the first lesson of each month, September - March. A 10% late fee applies after the 7th of each month. Late fees will also apply to all other recital/costume/competition fees after the 7th of each designated month. See below for fees schedule.

SNOW/EMERGENCY DAYS: On Pointe has built into its schedule two snow/emergency days for inclement weather and any other emergency that may cause the studio to close. If OPS is cancelled for inclement weather the studio will be closed for evening classes. On Saturdays the instructors will decide if there are safe driving conditions to hold classes. The studio will state on the answering machine if classes are cancelled by 3:00 p.m. during the week and by 7:30 a.m. on Saturdays. **Always call to make sure classes are cancelled.** If we do not use any snow/emergency days students will still have 36 lessons; 2 being free. If On Pointe cancels a class for any reason after the two snow/emergency days have been used, we will schedule make-up lessons/rehearsals.

Student absences will not be reimbursed. Students may make up an absence in another scheduled class if it is available. Please notify your teacher of your absences, as well as when you will be making up the missed lesson.

\$25 Costume Deposit per costume is due September 1st and November 1st. **The balance of recital costumes is due December 15th.** A costume statement will be handed out in November. This statement will show all fall fundraiser credits and deposits paid. Costumes are ordered on November 2nd!

\$125 Recital fee per family is due by October 1st. This fee covers costs associated with the rental of the auditorium, scenery, props, programs, tickets, etc. Our show is a private show. General admittance is prohibited. With their paid recital fee, each family will receive 8 tickets to the show and an email with recital music to download and practice with.

All costume and recital fees are non-refundable as of November 1st. Costumes are ordered on November 2nd. Once a costume has been ordered for your student, you are responsible for the full amount due.

If you drop out of class from September – January you are not responsible for future months tuition. However, as of February 1st you will be responsible for the rest of the year’s tuition.

REHEARSALS: 7-8, 9-10, Jr. High School and High School classes will be required to attend extra rehearsals in the spring. *No additional fees will be charged for these extra rehearsals.*

All students participating in the recital are required to attend the in-studio rehearsals and dress rehearsal during the week of recital. A schedule of these rehearsals will be handed out in March.
